CW Title and Escrow: Windermere (or its principal(s), through a separate entity or entities) owns less than 25% of WTG, LLC ("WTG"). WTG is an owner of Cascade West Title Company, LLC, which does business as CW Title and Escrow, CW Title, Whatcom Land Title Company, Whatcom Land Title, Baines Title, and Land Title and Escrow.
